    - Already about 10 weeks ahead of last year

  - o Jeof we are on our calendar, not on the national calendar yet because we don't have the registration up for advisors.
  - o No reason to wait on this.
- Jennifer in the meeting asked:
  - o If people aren't paying by credit card, Jennifer is going to send out invoices to unpaid in April?
  - o Jeof in shared drive, supplier registration spreadsheet
    - Those in green are paid

- Those not paid do need an invoice (template in the shared folder)
  - Also payment method instructions at bottom of invoice
- Working on first email to suppliers to thank them for registering
  - o Great FAQ that Heather and her team put together on supplier page
  - o Thank you Jeof for all these system
- In the new system, can we put something in the registration as to whether or not we can share attendees' email information?
  - o Per David Bowman (National), we can do an "opt in"
- Skyler and John and Sally talked about better connections between suppliers and attendees.
  - o Discussed using a passport or stamps, but that doesn't really promote conversation.
  - o Will use passport that requires less number of stamps, and will tell suppliers to only sign off if they spoke with attendee for at least 3 minutes
    - Must complete to be eligible for prize drawings
    - Presentations count for stamp
    - Discussed selling ads for the booklet, but decided against
  - o Paragraph about each supplier on the website?
    - After advisors register, send them a link with suppliers' logos, and the logos will be links to suppliers' websites.
    - Discussed video links from suppliers for introduction as well
    - Start putting this together May/June Jeof can coordinate
